

Mount Spacing






If cutting aircraft cable, ensure that at least 3 inches of additional length is exiting the cable adjustor. Aircraft cable may fray and decrease cable strength.



Power Drops


- Break off appropriate Knock Out. Either 5/8" or 7/8" KO.
- 2. Remove access plate.
- Feed power drop cord through KO, then secure power cord with strain relief.
- 4. Make electrical connections.

Note: If end of run, see End Cap installation section prior to re-installing access plate.




Joining


 Install first fixture (A) with two AC cable assemblies, then each additional fixture (B) with one additional cable at the opposite end of the joint.




- 2. Remove access plates on both fixtures.
- Install two biscuits, tap with hammer until biscuits fully engage.




- 4. Slide both fixtures together.
- 5. Secure fixtures using 1/4-20 x 1" Carriage Bolt and 1/4- 20 Keps Nut. Tighten using 7/16" wrench.



- Make electrical connections at joint. Tuck wires into fixture.
- 7. Re-install access plates.





- 8. At lens joint, install lens cover.
- 9. Repeat for all joints.



End Cap

- 1. Remove access plate.
- 2. Position end cap onto end of fixture and secure with two 8-32 x 1/2" self-tapping screws.
- 3. Slide decorative cover into end cap. Tighten using one 8-32 nut.
- 4. Re-install access plate.
